Underground Storage Tank Installation	\$75	Per site, Plan review and final inspection
Aviation Fueling Service	\$30	Annual, 1 inspection
Aviation Fueling Vehicle	\$15	Per vehicle, 1 annual inspection
Blasting Permit	\$30	Per site, 30 days
Blasting Permit Renewal	\$15	Per site
Fireworks Permit	\$30	Inspection day of display
Re-Inspection Fee	\$25	First follow-up inspection
Re-Inspection Fee	\$50	Second Follow-up inspection
Re-inspection Fee	\$100	Third and each subsequent follow-up inspection


